

This privacy policy sets out how Engage Procurement Ltd (trading as Procure.ie) collects, uses and protects any information that you provide to us in accordance with the European General Data Protection Regulation.

Data we collect and how we collect it:

In order to provide you with information about the products and services of Procure.ie and carry out a detailed savings analysis for your business, we need to collect certain types of personal data. This data may include:

- Personal information that identifies you such as name, job title, address, telephone numbers and email addresses.
- Previous utility bill information such as account number, meter number/reading, energy rates, bill total.
- If you are signing up with a supplier using our service we will require your bank account number and your sort code.
- The type of product/service you have signed up for including your contract type.
- Your consent to contact you with any other sign up offers or when your utility bill is due for renewal.
- Data that we receive from Third Parties where you have given them permission to share your data with us.
- We only collect information from you that you voluntarily submit to us electronically, via our website, over the telephone or in person and we will always inform you of the reasons why we request your personal data.

How we use your data:

- We will process your data to compile a report outlining the services available to you and cost savings your business can make.
- To contact you if required in connection with your account or enquiry and to respond to any communications you might send us.
- To provide you with information, products or services that you request from us or which we feel may interest you, where you have consented to be contacted for such purposes.
- We will process personal data for the duration of the contract for services and will store the data for 1 year after the date of termination of the contract. Payment details will be deleted after 3 months.
